# Colan Parish Council Meeting Wednesday 30th March 2022

## 1. Police Report:

No report received this month.

# 2. Public Speaking:

Andrew Brewer from Tregonning Farm outlined the plans for the proposed solar farm on his land. He stated that he would retain grazing rights which he already holds for this land. He said that the solar panels create a micro climate which improves the grass. No buildings will be destroyed to install the solar panels. He also stated that he is trying to help wildlife and the environment. The power lines will run to the power station at Indian Queens and there will battery storage provided. He is trying to make it mutually beneficial for everyone, investing back into the Community. The farm is already involved with Farm Net Zero and allows local schools to access the farm and spend days there. This application will be discussed by Councillors later in the meeting.

# 3. Cornwall Councillor's Report:

There have been some concerns around the addition of the sand school at Lane. The owner inadvertently took the hedge away instead of creating a wider entrance. The Planning Officer has visited site and permission has now been granted for this work.

The Duchy of Cornwall wish to use the name "Hendra" for their new live/work units which will be next door to the new recycling centre There is a meeting next week between the Duchy and Hendra Tourist park as obviously the name clashes with the Tourist Park which is an established business in the area. The Duchy have been asked to do a land swap so that they can build the new centre, however the Duchy are not in a hurry to do this. It will probably not happen until the NSR is complete.

Colan Parish Council will shortly be receiving a revised planning application for the Kings Head site. John wants to add a condition to the application stating that no construction should start until the NSR development is complete. Once the application is received the Council will discuss their response. Highways have decided to reject our application for speed awareness cameras on North Way and South Road as we are currently awaiting a response from our application for "twenty is plenty" signs. The contractors carrying out the safety work on South Road tried to erect a sign on land belonging to Newquay Garden Centre – they have now agreed to place it between Trethiggey Crescent and Garden

There is no further news on the Kinglsey site on land opposite the Goldings – they still want to put a supermarket on the site, but Cornwall Council has rejected this.

The Saints Trail will not be coming into Colan Parish; it is too late now to draw down the money. If it is resurrected it will end at Trevemper bridge.

A complaint has been received from the developers at Sunnyside that one of the residents of the bridleway had put large stones in place along the edge of the bridleway which prevents HGV's getting down to Sunnyside. This is ongoing at present.

A meeting has been held between Newquay Town Council, Sam Fuller from Cornwall Planning and the organizers of the Boardmasters Festival. It has been stressed that it is not appropriate for heavy traffic to access the site via Treloy Road., there does not appear to be any respect for local residents and businesses. A draft management plan has been submitted to Sam Fuller in the Planning Department.

Maurice asked what work the contractors are carrying out on Nansledan – there appears to be a large trench being dug across the site. John stated that he thinks it is a new water main and is part of the permitted development rights that the Duchy acquired for Nansledan, but will check exactly what it is for.
